 - Larry said not open yet. But he says that when they do open again, he will not be able to go back in. Said he has been communicating with Nate about it. Also said he has literature for H&I that's still laying around that he will turn over to Juli.
- vi. Women's Prison (Carol) [*Friday @ 7:00p*]
 - Still not open.
- vii. SL Behavioral (Jeremy F) [*Fridays @ 6:30p*]
 - Apologizes for his behavior last month. He is still going in. Jason will be taking over next week for the next little while. Collyn asked if Zylar would be interested. Jeremy advised about the background check and drug test. The two will try to talk soon.
